ADDITIONAL NOTES

In accordance with the BART Citizen Oversight Model (Model), OIPA investigates certain complaints, conducts complainant-initiated appeals, and also monitors and/or reviews complaint investigations conducted by BPD. Though potentially work-intensive, some complaint investigation reviews are completed informally, with any concerns being addressed through a conference with BPD's Internal Affairs investigators. Noting the various kinds of work that OIPA undertakes with regard to complaints and investigations, the following chart includes some of the pending cases in which OIPA is involved as of the end of this reporting period.

The Model provides that OIPA shall have authority to require follow-up investigation into any citizen complaint or allegation that is handled by BPD. The OIPA Monthly Report will reflect information regarding monitored cases with detail not to exceed that which is allowable under state law. The investigations reviewed by OIPA during the period did not generate any notable recommendations for revisions or additional investigation.¹²

³ This number indicates all investigations that are open as of the end of the reporting period. It includes Citizen Complaints (regardless of whether the investigation is being conducted by OIPA, the BART Police Department, or both) and Administrative Investigations.

⁷ The BART Police Department defines an Informal Complaint as, "A comment on the actions of a Department employee, where the reporting party expressly states that he or she does not feel that the matter should be formally investigated with the understanding that an Informal Complaint does not hold the potential to result in disciplinary action against the employee." (BART Police Department Policy Manual, Policy 1020.1.1(d)).

¹ In addition to reporting on complaints received by the BART Police Department, the Citizen Oversight Model requires reporting on all complaints received by the "Citizen Board, Office of the District Secretary, and other District departments." As complaints received by the BART Police Citizen Review Board are customarily directed to OIPA for further action, such complaints are included in the Quantitative Report above; OIPA is also made aware of additional complaints about the BART Police Department by the Office of the District Secretary or other District departments.

² This number includes all Citizen Complaints filed against members of the BART Police Department, as well as Administrative Investigations generated internally by BART Police Department members (as opposed to being filed by a citizen). ¹⁰ A Supervisor Referral refers to an instance involving an Inquiry or an Informal Complaint. An assigned supervisor addresses the issue informally with the involved employee and documents the content of the conversation with a memorandum to IA.

¹¹ Administrative Closure is defined as follows in the BPD Policy Manual: Allegations that are received and documented; however, the Chief of Police or his/her designee determines, based on a preliminary investigation, that further investigation in not warranted. Under these circumstances, the complaint will be Administratively Closed and documented in a summary memorandum to the case file. Employees will be documented as witnesses only, not as subjects to the complaint. Internal Affairs will send a letter to the complainant notifying them that the case was closed following a preliminary investigation.

¹² OIPA may submit recommendations to IA regarding minor clerical or record-keeping adjustments which are intended to maintain the integrity of the data collection and record-keeping processes at BPD. These are not considered by OIPA to be substantive recommendations requiring reporting herein.

SUBJECT: Proposed Revisions to BPD Policy #451 – Body Worn Camera

BART Police Department (BPD) Policy 451 – "Body Worn Camera" is intended to assist officers in the performance of their duties by providing an objective, unbiased video and audio record of a contact and/or incident. According to the language of the policy, officers are required to utilize the AXON camera in accordance with the provisions of the policy in order to maximize the effectiveness of the device, enhance transparency, and ensure the integrity of evidence.

Pursuant to the above requirements of the Model, the Office of the Independent Police Auditor (OIPA) developed recommendations for changes to Policy 451 which were presented to the BART Police Citizen Review Board (BPCRB) at its February 11, 2019 regular meeting, during which the BPCRB endorsed each of OIPA's recommendations by a majority vote (7 yes votes, 1 abstention, 2 absences).

OIPA now revisits its review of Policy 451 and renews some of the previously submitted recommendations while adding additional recommendations that were not discussed in February 2019 and which appear appropriate in light of ongoing review of BPD activities. The information contained herein is intended to reopen discussion about outstanding aspects of OIPA's previous recommendations.

As discussed in greater detail below, OIPA suggests:

- I. Adjustments to the requirements for labeling body-worn camera video recordings to improve accuracy and to discontinue the deletion of evidence that must be retained to facilitate criminal prosecutions and investigations, to maintain accountability and transparency, and to promote public safety and officer safety. The use of internal audits to ensure compliance with policies and performance expectations.
- II. Clarification of the body-worn camera activation requirements to include any contact during which BPD personnel require compliance with commands or instructions and where non-compliance with those commands will result in a detention or arrest.

- III. Reprogramming the AXON body-worn camera to record audio during the pre-activation buffering period in order to more consistently capture verbal commands and responses during law enforcement contacts.
- IV. Revisiting discussions with the manufacturer to resolve the ongoing problem of detaching cameras and/or issuing tactical vests to all officers.
- V. Requiring all sworn BPD personnel to wear and activate body-worn cameras during law enforcement activities regardless of rank.

<u>Authority</u>

Chapter 1-04(K) of the Citizen Oversight Model (Model) states that OIPA shall develop recommendations concerning General Orders and Directives, procedures, practices, and training of the BPD, with the goal of improving professionalism, safety, effectiveness, and accountability. The Model further requires that OIPA consult with the Chief of Police and other stakeholders and present its recommendations to the BPCRB for review and comment.

The Model also provides that should BPD reject policy recommendations submitted by OIPA, the Independent Police Auditor (IPA) may forward the recommendations to the BART General Manager (GM) and/or the Board of Directors for further consideration. OIPA must publicly report on its involvement in the development and revision of BPD policies and must report annually regarding any outstanding recommendations and the degree to which they were endorsed by the BPCRB and accepted by BPD.

Prior Recommendations (February 2019)

In February 2019, OIPA proposed the following revisions to the existing policy with specific language to be determined through discussion and collaboration between then-BPD Chief Carlos Rojas, the BART Police Officers Association (BPOA), the BART Police Managers Association (BPMA), BPD command staff, the BART Police Citizen Review Board (BPCRB) and OIPA:

- Update language to reflect equipment and technology upgrades
- Require Chief of Police's or designee's authorization to view critical incident recordings
- Specify and define a "timely activation"
- Reprogram AXON camera buffering period from 30 seconds to 60 seconds with audio
- Add language requiring AXON recording auditing by BPD personnel
- Add language regarding OIPA's review of fare inspection activities
- Require officers to notify supervisors each time a camera becomes dislodged
- Specify and define a "law enforcement contact"
- Require confirmation of equipment failures via review of required equipment tests

After review and endorsement by the BPCRB, BPD command staff conferred with representatives of the BPOA and BPMA and ultimately implemented a revised policy reflecting most of the above recommendations. Since February, some new and some continuing concerns related to the policy and related to Departmental practices have emerged and are detailed below.

I. Inaccurate Labeling and Evidence Deletion

A. <u>Test Videos</u>

Existing policy language requires that each officer shall perform an inspection and record a test video prior to going into service to ensure that his/her AXON camera is operational. OIPA recently discovered that a significant number of recordings of law enforcement contacts were improperly labeled as a "TEST," which then queues those recordings for permanent deletion after 30 days.

Due to this inaccurate labeling, recordings which may have been of value to BPD (related to public and officer safety concerns, crime prevention, deployment decisions, internal audits, criminal prosecution, and/or misconduct investigations) and OIPA (related to audits, monitoring activities, use of force review, and/or complaint investigations), and which were intended to be maintained, were irretrievably deleted.¹ Recordings queued for permanent deletion in this way included the following:

- An officer responding to a call of a person with a gun during which officers drew both lethal and "less-lethal" weapons.
- The response of heavily armed officers involved in extracting a barricaded subject from a BART utility area.
- A search for a subject reported to have brandished a knife.
- A call for service in response to the battery of a BART station agent.
- The ejection of a 16-year-old subject from a train for smoking.
- The mental health commitment of a subject.
- Sweeps of trains at the end of revenue service, including ejection of individuals from the BART system.
- Enforcement of the BART Proof of Payment Ordinance by civilian Fare Inspectors.
- Fare evasion enforcement contacts by sworn officers.
- The inspection of evidence stained with a substance suspected to be blood.
- The custodial interrogation of an arrestee.

¹ There is an existing protocol for the deletion of accidental recordings, which includes review by a supervisor and an administrator prior to deletion. Typically, officers do not adhere to the established protocol, and instead routinely label accidental recordings as a "TEST."

After identifying a significant number of improperly labeled recordings, OIPA recognized that efficacious methods of preventing ongoing misuse or potential abuse of the evidence.com storage system might include performance of the required BPD supervisory audits, revisions to Policy 451 as suggested herein, re-training of officers and supervisors, and/or resetting of data entry parameters within evidence.com.²

To determine the best course of immediate remedial action, OIPA contacted Interim BPD Chief Alvarez and requested an immediate temporary adjustment to the retention period for TEST videos, so that BPD supervisors could effectively audit and identify any misuse or abuse of the evidence storage system without any further permanent loss of data.

OIPA believes that the BPD Chief is authorized to unilaterally adjust retention schedules for recordings based on language in Policy 451 that states, "…retention times can be extended at any time by a Supervisor, Internal Affairs, Evidence Specialist, BPD System Administrator for evidence.com, or by the Chief of Police or his/her designee."

In a laudable and reasonable effort to prevent BPOA and the BPMA representatives from incorrectly perceiving that BPD management and/or OIPA sought to adjust the retention period without notification to the Associations, Interim Chief Alvarez elected to communicate with the two Association representatives. Interim Chief Alvarez then reported to OIPA that the Association representatives were not amenable to a temporary 60-day extension of the retention period, nor were they willing to engage in discussions with the Interim Chief or the IPA about the apparent destruction of evidence or a plan to discontinue such destruction.

BPD currently provides 12 different categories with which officers and Fare Inspectors can tag their recordings. OIPA suggests the addition of categories such that each recording is properly and accurately labeled and such that only equipment tests are labeled as such. OIPA further suggests that the required supervisory audits are conducted in such a way as to confirm that each officer or Fare Inspector conducts only one daily test, and that no other recording, in particular any recording intended to be retained, is incorrectly labeled.

B. Video Titles

OIPA has also noted and reported to BPD that titling of recordings is inconsistent and frequently unconventional, making identification and retrieval of relevant video more difficult and timeconsuming. OIPA previously proposed the addition of language requiring regular periodic auditing by BPD personnel of the accuracy and consistency of video labeling, titling, and categorization

pursuant to Section 451.2.1. There is no indication that these audits have been performed, and OIPA here renews the recommendation that these internal audits be regularly and thoroughly performed. Pursuant to the Model, OIPA intends to monitor any and all internal audits of body-camera recording and labeling conducted by BPD.³

Potential remedies for inaccurate titling may include reprogramming of the interface such that only properly formatted entries will be accepted and/or that supervisors are automatically notified when officers' recordings are uploaded to evidence.com with a blank title field.

C. <u>Supervisory Audits</u>

Relatedly, the obligatory supervisory audits may be an effective tool to ensure that officers are engaging in required activities during shifts. For example, to the extent that District intends to prioritize increasing the perception of officer presence by requiring officers to walk through trains, activating the AXON unit and recording these walkthroughs may help confirm that the BART GM, BPD Command Staff and BPD supervisors' expectations are being met. OIPA also recommends the use of internal audits to review whether other expectations related to the performance of all assigned duties are being conducted.⁴

II. Activation Requirements

A. Expand the Definition of a Contact Requiring Activation

1. End-of-Revenue Sweeps

OIPA previously recommended the addition of specific language clarifying the definition of a law enforcement contact requiring activation of the AXON camera. OIPA is aware that officers do not typically activate cameras during end-of-revenue sweeps of the trains and stations. Predictably, some of these ejection activities rapidly and dynamically develop into a use of force incident, which cannot then be thoroughly analyzed in the absence of a complete video recording.

OIPA suggested the inclusion of additional language clarifying that any contact during which an officer issues a command or makes a demand for compliance therewith qualifies as a law enforcement contact. After consultation with the BPOA and BPMA representatives, BPD rejected that recommendation and implemented policy language specifying that camera activation is

required prior to the ejection of a subject from a BART station or train only in instances where the subject does not immediately comply. OIPA does not agree with this construal and has not been presented with a reasonable justification for the exclusion of recordings of officers instructing people to exit trains and stations under threat of detention or arrest for non-compliance. OIPA believes that these activities must be recorded, among other reasons, to ensure that any related use of force or complaint can be properly examined.

2. Consensual Contacts

The existing policy also provides that officers are "encouraged" to activate the camera during consensual contacts. OIPA believes that despite this encouragement, many BPD officers do not activate the AXON camera during consensual contacts.⁵ The consequences of this language include repeated failures to record the issuance of initial verbal commands where the failure to comply may then be (and has been) put forth as justification for the application of physical force and/or arrest.

OIPA believes that any escalation from an educational, informational, or consensual interaction to a law enforcement contact necessarily imbues the initial verbal exchange with great importance and significant relevance to the analysis of any subsequent use of force, detention, or arrest. For this reason, these interactions should be recorded and preserved. OIPA is unaware of any persuasive argument that on-duty verbal interactions between an officer and a citizen should be excluded from the recording requirement.

3. Early Morning Ejections

Recently, BART management and BPD reported that 500 unticketed passengers have been ejected from the system every week since the end of September 2019 during early morning "train sweeps" conducted at the Embarcadero Station in San Francisco by Fare Inspectors and sworn officers.⁶ OIPA review of recordings stored in evidence.com indicates significant ongoing underactivation by the sworn officers engaged in these ejections. Because each of these ejections amounts to a law

enforcement contact including verbal commands with which a subject must comply, every sworn officer acting as cover and/or support for the Fare Inspectors must activate their camera pursuant to existing language in the policy.

OIPA recommends that BPD supervisors and command staff take action to instruct all sworn officers engaged in these operations to activate their cameras prior to ejecting or participating in the ejection of passengers who are unable to produce proof of payment.

III. Silent Buffering Reprogramming

In February 2019, OIPA suggested that BPD reprogram the AXON camera buffering period from the current 30-second setting to a 1-minute buffering period including audio. Currently, reviewers can access 30 seconds of silent video recorded prior to activation of the camera. Following submission of the OIPA recommendations to BPD and endorsement of those recommendations by the BPCRB in February, the implemented version of the policy did not reflect adoption of the recommendation related to the reprogramming of the cameras.

During the course of routine review of use of force incidents, OIPA determined that more than 25% of all reviewed incidents included an arguably late or failed activation by involved officers.⁷ Some of these policy violations were not acknowledged, memorialized, or properly addressed by BPD reviewers. Some supervisory use of force reports included language indicating that activations were timely because the silent (buffering period) video footage captured all or some portion of the actual application of physical force by the involved officer(s).

OIPA believes that a thorough review of every use of force must include analysis of officers' verbal commands and of the verbal responses to those commands. In this way, assertions of non-compliance with commands can be corroborated or debunked. The absence of audio during the buffering period weakens any conclusions that may be reached by relying solely on the officers' characterization of events.

In the 10-month period prior to the submission of the above recommendations to the Department for implementation, BPD sustained approximately 36 AXON violations. In the 10-month period following the BPCRB endorsement of the suggested revisions and submission to the Department, BPD sustained approximately 24 AXON violations. While there has been an apparent reduction in detected and memorialized AXON violations, OIPA continues to see late or failed activations deemed within policy by supervisors in connection with the use of force review process.

A. Non-Disciplinary Remedial Action

In connection with this proposal and as an incentive for endorsement by BPOA and BPMA, OIPA suggested that officers who activate their cameras after the initiation of a law enforcement contact, but still capture the entirety of a use of force (both audio and video) during the pre-activation buffering period would receive a Training Point⁸ regarding the late activation in lieu of disciplinary action. Disciplinary action includes the escalation of discipline pursuant to the Association-negotiated progressive discipline process. This recommendation was put forth as a technological solution for inevitable human error related to dynamic and rapidly evolving circumstances and was expected to reduce the disciplinary consequences of late activations while increasing the ability of the Department and OIPA to review video related to citizen complaints, administrative investigations, and criminal investigations.

IV. Equipment Failure

As OIPA has already discussed with BPD, there has been a significant increase in dislodged cameras since the distribution of the AXON Body 2 camera. Any lack of supervisory awareness of this equipment issue may increase the likelihood that a critical incident would not be captured on video because such lack of awareness may delay the Department's efforts to seek a remedy from the manufacturer.

Although OIPA is confident that BPD Command Staff are aware of the problem with detaching equipment, little has been done to implement an effective remedy for the entire Department. While some officers have started using tactical vests which appear to obviate the detachment problem, many officers still use the manufacturer-issued magnets which are insufficient during many use of force incidents and allow the equipment to detach from an officer's uniform during physical interactions.

Internal BPD audits should include review of whether detached cameras were reported to supervisory personnel and BPD management should insist that AXON discuss hardware improvements to mitigate the problem. BPD should also consider issuing tactical vests to all officers.

V. Equipment Distribution

Lastly, the existing policy language requires only that BPD sergeants, officers, and Fare Inspectors will be provided with AXON equipment. OIPA is aware that Lieutenants and Deputy Chiefs may also engage in law enforcement activity, particularly as BPD works to maximize the impact of an

understaffed Department. OIPA suggests revising the policy language such that any BPD officer of any rank should be required to wear and activate a body-camera while engaged in patrol activities.
